major Florida homeowners' insurer. In 2022, the insurer went bankrupt and was placed in receivership. The Florida Department of Financial Services (DFS), as receiver, accused the D&Os of mismanaging the insurance company (breaching the D&Os' fiduciary duties) and causing the bankruptcy and over \$100 million in damages. At mediation: (1) we attacked the DFS's inability to prove causation (that the insolvency was not caused by other, external factors, like hurricanes and a uniquely challenging insurance litigation landscape); and (2) focused on the strength of the D&Os' business judgment rule defense.

Represented Electrolux, a Fortune 500 company, in the transfer of its warranty portfolio to OnPoint Warranty Solutions, LLC, to be reinsured by Zurich Insurance Group. The transaction involved two transfer tranches (each requiring a separately negotiated agreement) and a 95-page administration agreement to govern the parties' relationship going forward.
