#### Experience

Obtained a verdict and judgment totaling \$550,000 in Webster Parish, Louisiana following a bench trial on behalf of a builder's risk insurer in a case involving an electrical fire to a custom log home under construction. The case subsequently settled pursuant to a confidential settlement agreement.

Obtained a verdict and judgment totaling more than \$6 million in Dallas County, Texas following a bench trial for a builder's risk insurer in a case involving electrical damage to an apartment complex caused by the negligence of an electric utility company. The electric utility company's highest offer before trial was \$300,000. The case subsequently settled pursuant to a confidential settlement agreement.

Confidential settlement for insurer of Little Rock, Arkansas ABC-TV affiliate arising from the collapse of a 2000' tall TV transmission tower. The case involved an extensive forensic investigation of the collapse spanning several weeks, as well as a complex damage model for recovery of the market value of the 40-year old tower, emergency mitigation expenses and lost profits arising from the loss of use of the tower during a critical sweeps week.
