Prior to assuming that position, Toth served as Director of Operations for Capital Plan Management with the NYC School Construction Authority, overseeing the Department of Education's five-year \$11.1 billion Capital Plan; and as a Legislative Financial Analyst, providing financial guidance on the Department of Education's \$13.5 billion Capital Plan and CUNY's \$307 million Capital Plan.
