Experience

Successfully represented multiple subrogees in connection with a massive wildfire in Texas that covered more than 700 acres and destroyed more than 1,500 homes.

Represented a Montessori school in the successful appeal from an adverse judgment which resulted in the withdrawal of the case by the plaintiff in Collin County, Texas.

Several recoveries against security guard companies for failing to protect the subject property pursuant to the terms of the security guard contract.

Recovered in excess of \$6,000,000 against an electrical sub-contractor for the negligent installation of underground electrical cables which caused a fire at a new apartment in Dallas.

Prevailed in an arbitration hearing before a panel of three commercial arbitrators against a roofing company for the negligent installation of a new roof on a warehouse which caused the roof to collapse during a thunderstorm.

Recovered 100% of his client's damages in the Southern District of Texas in a bench trial against the U.S.A. in a case involving the Federal Tort Claims Act and damage to a radio/television tower with no fair market value at the time of the loss. We argued the tower had significant value to the owner, the local PBS station.

Argued before the Texas Supreme Court as an amicus curiae on behalf of a property and casualty carrier in a product liability case involving a child's use of a defectively designed cigarette lighter.

Recovered 100% of his client's damages in three arbitrations against the manufacturer of defective washing machine hoses. This resulted in the successful settlement of over 90 claims against the manufacturer on behalf of a major property and casualty carrier.
