# Experience

Obtained an appellate victory for the insurer in a coverage dispute stemming from a tragic and highly publicized accident at a sponsored amateur drag race, after which the injured families filed a lawsuit against the event's sponsor. The insurer had issued a 24-hour CGL policy to cover the event, but it excluded "bodily injuries" including death arising from a "motorized vehicle" accident. Reversing an unfavorable ruling by the district court on the parties' cross-motions for summary judgment, the U.S. Court of Appeals for the Fifth Circuit cited many of the arguments set forth in our brief and during oral argument, and remanded to the trial court with instructions to grant the motion for summary judgment and hold that the insurer has no duty to defend or indemnify.

Won summary judgment, and successfully defended appeal of same, for an insurer on a COVID-19 business interruption claim filed in Texas state court for which the client's potential exposure was approximately \$25 million.

Advise property insurance companies regarding policy forms and construction and provide coverage advice relating to catastrophe claims, COVID coverage under property policies, and obligations in responding to policyholder demands.

Routinely advise insurance carriers regarding obligations and options when presented with policy limits demands.
