Jim also handles corporate investigations and provides his clients with general business counseling on a variety of topics. He has considerable experience prosecuting and defending temporary restraining orders/injunctions and other equitable relief matters.

Jim regularly represents clients ranging from sole proprietors and practitioners to large corporate entities and institutions, both in pursuing claims and in defending and trying or arbitrating lawsuits in various complex commercial litigation matters. He has experience representing technology based companies, manufacturers, retailers, hospitals, medical professionals, insurance producers, law and accounting firms and individual lawyers and accountants, against claims and potential claims and with respect to subpoenas for depositions and records, administrative proceedings, criminal matters, and risk management issues. Jim's successful representations have involved winning cases through dispositive motions and at trial or through arbitration when necessary. He also has experience defending multiple Illinois Biometric Information Privacy Act (BIPA) class action clients in various business segments including the manufacturing, software, health care, temporary staffing, technology, and service industries. He also represents BIPA defendants in "mass arbitration" actions where he leads complex litigation/arbitration strategies. In addition to BIPA class actions, Jim has handled class actions asserting false claims act and consumer protection claims.

Jim is admitted to practice in the state of Illinois, the U.S. District Court for the Northern District of Illinois, including the Trial Bar, the U.S. District Court for the Central District of Illinois, the U.S. District Court for the Eastern District of Michigan, and the U.S. District Court, District of Colorado and has been involved in federal and state court litigation around the country. Council representative, and has volunteered in the Chicago Public School System, District 64 School System, the Chicago Greek Orthodox Archdiocese, the American Hellenic Educational Progressive Association (AHEPA), the Hellenic Bar Association of Illinois, and the Park Ridge Police Parent Patrol.

Jim received his bachelor's degree, *summa cum laude*, from the Honors Department, in economics from Loyola University of Chicago in 1992 and served as a student representative on the Loyola University Board of Trustees. He received his law degree from Loyola University of Chicago Law School in 1995 where he served as law review executive editor and as an assistant Legal Writing/Moot Court instructor. Jim is fluent in Greek.

Experience

Won a motion to dismiss in a case brought under the Illinois False Claims Act in which plaintiffs alleged that the client violated the law by causing authorized retailers of certain phone devices to fail to collect and pay to the State Department of Revenue an Illinois-specific sales tax on a charge for setting up the devices at the time of purchase.

Successfully tried a federal court case that resulted in a verdict in favor of our client, an international commercial real estate owner and landlord, against the claims of one of its major tenants in a prominent downtown Chicago commercial space, regarding allocation of millions of dollars of expenses relating to the tenant's lease and use of the property.

Served as part of the trial team that defended a multimillion dollar claim in federal court alleging violations of copyright law against an author and producer of a popular book and movie. The case was tried before a jury that returned a verdict in our client's favor.

Prevailed in a FINRA arbitration on behalf of a banking industry client facing a competitor's claim that the client had a pattern or practice of hiring the competitor's former employees and causing them to breach non-solicitation agreements. The arbitration panel not only rejected the claimant's requests for a nationwide permanent injunction and monetary relief, but also entered an award of attorney's fees and costs in our client's favor.

Served as part of the team of attorneys representing an association of approximately 3,500 retirees, in pursuit of their bankruptcy claims in one of the largest bankruptcies of its kind. The representation included proceedings before the bankruptcy and district courts, the 7th Circuit Court of Appeals, and the U.S. Supreme Court. Our representation resulted in a substantial extension of pension and insurance benefits for our clients.

Successfully defended our clients, an investment company and its board of directors, by obtaining summary judgment on all claims filed in a chancery court shareholder derivative action brought by minority shareholders of the company challenging certain stock options.

Successfully defended high-profile temporary restraining order companion cases filed by a public interest group against our client relating to a public-private construction project on public property, obtaining dismissal for our client and reimbursement of attorneys' fees.

Won summary judgment on behalf of both a landlord and a tenant of a large commercial property in the Chicago suburbs who were sued by an individual alleging significant damages for personal injuries sustained when she encountered alleged hazardous conditions along a pathway between a public roadway and the clients' fence line. After we gave the plaintiff notice of our intent to file a motion for summary judgment, the plaintiff filed a motion to voluntarily dismiss the case. To prevent our client from being hauled back into court should the plaintiff re-file her case within a year (as would have been her right), we filed our motion as planned and convinced the judge that the plaintiff's motion for voluntary

dismissal was merely an attempt to avoid a ruling on the merits. After allowing the motion for summary judgment, the court dismissed all claims against our client with prejudice.

Represented a school district board and administrators in a lawsuit filed in federal court, obtaining dismissal with prejudice of complaints arising out of a student's special education asserted under the American with Disabilities Act and the Civil Rights Act and successfully defended the dismissal in the Court of Appeals for the 7th Circuit.

Obtained dismissal with prejudice of a high-profile case filed against a group of investors who secured zoning approval for the construction and operation of a firearms safety training and firing range in suburban Chicagoland, described as the "Apple store of the firearms industry." An advocacy group sued in an effort to stop the project, arguing that the zoning approval unconstitutionally violated the rights of neighboring property and business owners. The years-long trial and appellate court litigation centered on issues relating to the Second Amendment, the Illinois Constitution, zoning challenge standing, and separation of powers between the judiciary and the municipality that approved the zoning ordinance.

Successfully moved to dismiss a defamation claim filed against our clients in the wake of a wrongful death action. We then won summary judgment on a malicious prosecution claim stemming from the same case. This result was affirmed on appeal.

Counsel and advise a regional cell phone tower construction and engineering company with respect to non-compete issues.

Counseled and advised a health care provider with respect to its restrictive covenant agreements.
