The government settled the investment claims with the claimant without payment and successfully defeated material breach applications from the claimant, with all claims having been dismissed and the settlement remaining in force.

Under the auspices of the Singapore International Arbitration Center, he prosecuted a \$500 million breach of contract case. His international arbitration experience includes several cases before the International Chamber of Commerce in Germany, Switzerland, and Hong Kong and other arbitral regimes including the SCIA, PCA and HKIAC. In the United States, he helped negotiate the acquisition of the third-largest textile manufacturer in the United States by the largest European hosiery manufacturer and successfully defending the European firm in a \$600 million breach of contract action.
