

# John K. McDonald, former Toll Brothers, Inc. General Counsel, Returns to Cozen O'Connor

McDonald began his career in 1990 as a prosecutor in the Philadelphia District Attorney's office and, over a five-year career, tried more than 30 jury trials and hundreds of bench trials, as well as arguing cases before the appellate courts. In 1995, after successfully prosecuting a front-page, high-profile criminal case, he accepted an offer to join Cozen O'Connor, one of the country's most prominent commercial litigation firms.

In 2002, McDonald left the firm to join Toll Brothers, a firm client and a Fortune 500 company that operates in 20 states and generated \$7.1 billion in revenues in 2019. He began as the company's chief litigation counsel, overseeing a litigation docket of hundreds of complex commercial cases, and then quickly moved up the line, becoming deputy general counsel in 2007 and general counsel and chief compliance officer in 2010. While at Toll Brothers, he had wide-ranging responsibilities, which included corporate/securities, litigation, transactional, acquisitions, regulatory, corporate governance, investor relations, government investigations, risk, and compliance.

"Today's business litigation is more demanding than ever. The stakes are higher and the cases are much more complex," said Michael J. Heller, Cozen O'Connor's Executive Chairman and Chief Executive Officer. "As a Fortune 500 General Counsel for the last 10 years, John brings to us the business acumen today's commercial litigators need to assess major, multi-district corporate disputes and develop a legal strategy that best fits the business needs of the enterprise."
