Her practice has involved conducting internal investigations for corporate clients; MDL litigation; managing pre-trial discovery and motion practice; assisting clients in implementing corporate compliance programs; representing clients in domestic arbitrations; and state and federal appellate briefing and oral argument.

An issue of first impression involving cross motions for summary judgment, the federal court in Harrisburg, Pa., ruled against the school district's argument that the agreements were unenforceable because the related bonds had never been issued.
