As a presidential appointee, Bhirud has also served as deputy general counsel for the U.S. Department of Homeland Security in Washington, D.C. He managed all Homeland Security high-stakes litigation and appeals; created a litigation plan to identify and resolve lawsuits with a potential for significant judgments; and supervised 1,400 attorneys over six agencies conducting regulatory actions, investigations, litigation, and appeals.

Fluent in Marathi, Bhirud has been recognized by Chambers & Partners, State Attorneys General Practice - Nationwide, 2023, and was recognized repeatedly as a Nevada Super Lawyer.
