# **Aviation Regulatory**

Mike advises U.S. and foreign passenger and cargo airlines, Part 380 public charter operators, aviation industry trade associations, aircraft ferry operators, global business jet companies, and advanced air mobility/air taxi and uncrewed aircraft system (drone) operators and manufacturers on the full array of U.S. aviation laws and regulations, including those enforced by the U.S. Department of Transportation (DOT), the Federal Aviation Administration (FAA), the Transportation Security Administration (TSA), and U.S. Customs and Border Protection (CBP).

## Aviation Security/TSA Compliance

Mike advises airlines, airports, aviation security vendors, indirect air carriers, authorized representatives, and other entities directly and indirectly regulated by TSA on compliance with TSA's regulations and specific TSA programs, such as TSA's Full All-Cargo Aircraft Operator Standard Security Program (FACAOSSP), Aircraft Operator Standard Security Program (AOSSP), Indirect Air Carrier Standard Security Program (IACSSP), Foreign Air Carrier Model Security Program (MSP), Certified Cargo Screening Program (CCSP), and Certified Cargo Screening Program – Canine (CCSP-K9). He regularly counsels clients on TSA's administrative investigations and civil enforcement actions, and has successfully mitigated proposed TSA civil penalties.

As part of his TSA compliance work, Mike has conducted detailed reviews of client TSA programs and participated in on-site client audits to identify potential compliance concerns and improve clients' TSA compliance posture. He advocates for a practical common sense approach that balances business considerations with regulatory compliance.
