Lewis's legislative work in Albany has impacted virtually every corner of the state. He recently led, for example, a statewide coalition that increased the 2023 fiscal budget for the Affordable Housing Corp. (AHC) — a state-funded grant program that subsidizes homeownership statewide — to \$36 million from \$26 million, where it had been since the program's inception in 1985. Further, Lewis helped secure a pool of \$400 million in affordable homeownership funding for the AHC's parent, the Division of Housing and Community Renewal. In 2019, he helped spearhead the unanimous, bipartisan passage of a bill increasing the AHC's per-home subsidy from \$45,000 to \$75,000 in high-cost markets like New York City.

In 2022, Lewis was named to the annual "40 under 40" list published by *Crain's New York Business* — recognizing his work with Habitat for Humanity, the global nonprofit that develops affordable homeownership for low-to-moderate income Americans. A Brooklyn native and resident, Lewis's efforts have also positively impacted his hometown. He was directly involved, for example, in the recent creation of 485 homeownership units and 123 units of affordable LGBTQ senior housing in New York City.
