His responsibilities included contract negotiation, design development, constructability reviews, construction planning and oversight, risk analysis, budget development, change order negotiation, and coordination between teams and outside counsel. Represented a steel fabricator/installer for a six-story, four-block train and bus transit center construction project (the Transbay Transit Center), in connection with affirmative and defensive claims in the millions that were resolved via settlement.

Served on the trial team in a 12-week jury trial centered on the SR91 Corridor Improvement Project, a design/build 16-mile highway widening project (>\$700million) that included more than 30 bridges and 45 retaining walls. Second chaired major technical claim defenses (including alleged underallocation of rebar in bridges, design of bridge foundations, underallocation of retaining walls, and alignment revisions), managed all experts for these issues, and handled more than 15 depositions. Secured dismissal of each of these claims, and 98 percent of overall claims asserted in the case.

Second chaired a four-week jury trial centered on the construction of sewer lift station (Ranger Lift Station No. 16), representing a municipality defending against \$700,000 in claims for delays and increased costs. Handled all pre-trial preparation of documents, witnesses, and experts to show that the contractor was responsible for the delays and added costs and secured a complete victory for the client, including an award of attorneys' fees.

Second chaired a three-week jury trial involving the Los Angeles Unified School District's construction of 30 kitchen remodel projects, representing a contractor defending against \$5 million claims to rescind contracts to reduce the value of signed agreements. Handled the testimony and cross-examination of percipient and expert witnesses for trial, and secured a victory for the client.

Recovered 85 percent of all claims on behalf of a general contractor in a five-day arbitration involving a dispute with a steel subcontractor seeking costs for delays and defects in connection with the construction of seven buildings for the Marines at Camp Pendleton (a \$50 million project). Served as second chair, responsible for preparation of claims, documents, and witnesses.

Represented a general contractor against a subcontractor in connection with claims for delay costs and additional false claims allegations involving the construction of a higher education building for a college (Exotic Animal Training and Management Facility, Moorpark, Cal.). Second chaired the two-day bench trial, resulting in dismissal of the opposing party's claims. Also assisted in separate litigation to dismiss False Claims Act allegations against our client.
