Assisted a brewery with its business formation and related filings.

Obtained summary judgment from a state trial court in a breach of contract case involving a residential lease.

Defended a franchisor in an arbitration proceeding on 26 counts, including breach of contract, fraudulent inducement, and deceptive trade practices.

Won summary judgment on behalf of a landlord in litigation against a restaurant tenant (and its guarantor) who stopped paying rent and abandoned the premises due to business decline following COVID-19 and government-mandated closures. In granting summary judgment, the court rejected the tenant's common law defenses of impracticability, frustration of purpose, and illegality as against public policy. Because summary judgment was granted against both the tenant and the guarantor, the client was able to apply for an award of all attorneys' fees.

Assisted a landlord with COVID-19 related lease negotiations and settlements.

Represented an owner of distressed real estate through a foreclosure by action, and resolved complex lien and mortgage priority issues.

Represented landowners in a driveway easement dispute in state trial court, resulting in a favorable easement agreement.

Filed 11 separate lawsuits in the Court of International Trade, on behalf of as many clients in September 2020, directly challenging the validity of the third and fourth waves of tariffs the Trump Administration imposed in 2018 on goods imported from China. In loose collaboration with other leading trade practitioners, representing thousands of plaintiffs altogether, the suits contend the tariffs are invalid because the U.S. Government did not act with legitimate regulatory authority in imposing them.

Won a crucial motion to dismiss claims against our coal industry clients in eleven environmental lawsuits filed in the federal district court in Minneapolis. The cases centered on coal tar, a byproduct of the refinery process, that was sold to manufacturers who used it in asphalt sealant. Various Minnesota municipalities filed separate federal lawsuits against a variety of coal refiners and asphalt sealant manufacturers, including our clients, alleging claims including defective design, fraud, nuisance, trespass, and breach of warranty. All of the claims were premised on the notion that coal tar in the asphalt sealant broke down and contaminated stormwater maintenance ponds. These cases, the first in the country, appeared to be a template for further actions in other states, until the court granted our motion to dismiss as to all claims against all refiner defendants.

Secured dismissal of claims brought on constitutional grounds against the Federal Housing Finance Agency, in its role as conservator and receiver of the Federal National Mortgage Association ("Fannie Mae") and the Federal Home Loan Mortgage Corporation ("Freddie Mac"), by private investors seeking to nullify a series of agreements with the U.S. Department of the Treasury under which Treasury loaned Fannie Mae and Freddie Mac approximately \$187 billion in return for the companies' entire net worth less a capital buffer and a liquidation preference essentially equal to the loan. The plaintiffs argued that FHFA's director was unconstitutionally appointed and the actions of FHFA were unconstitutional, which the district court rejected. When the U.S. Supreme Court later held that the similarly appointed director of the Consumer Financial Protection Bureau had been unconstitutionally appointed, the U.S. Court of Appeals for the Eighth Circuit remanded the FHFA case back to the district court to determine whether the plaintiffs could allege any harm as a result of the unconstitutional appointment of the FHFA
